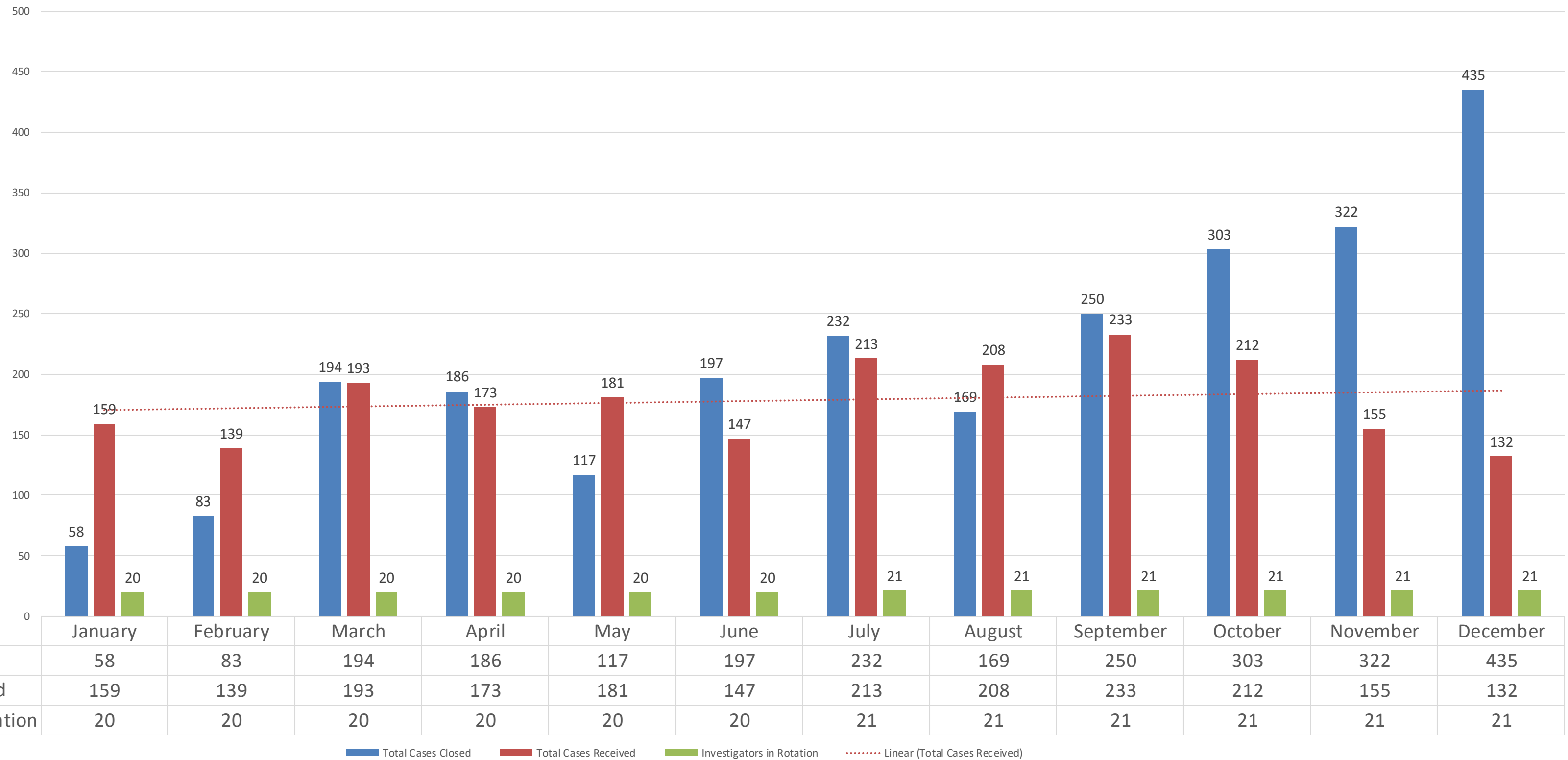

OCI's Progress

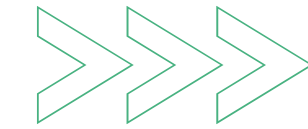
We are closing cases significantly faster than they are coming in. YTD, we have closed **2,546** cases while receiving **2,145** new complaints. This efficiency is what allowed us to cut the total open caseload by **44%** from 4,856 (2,711 + 2,145) to 2160.

CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2025



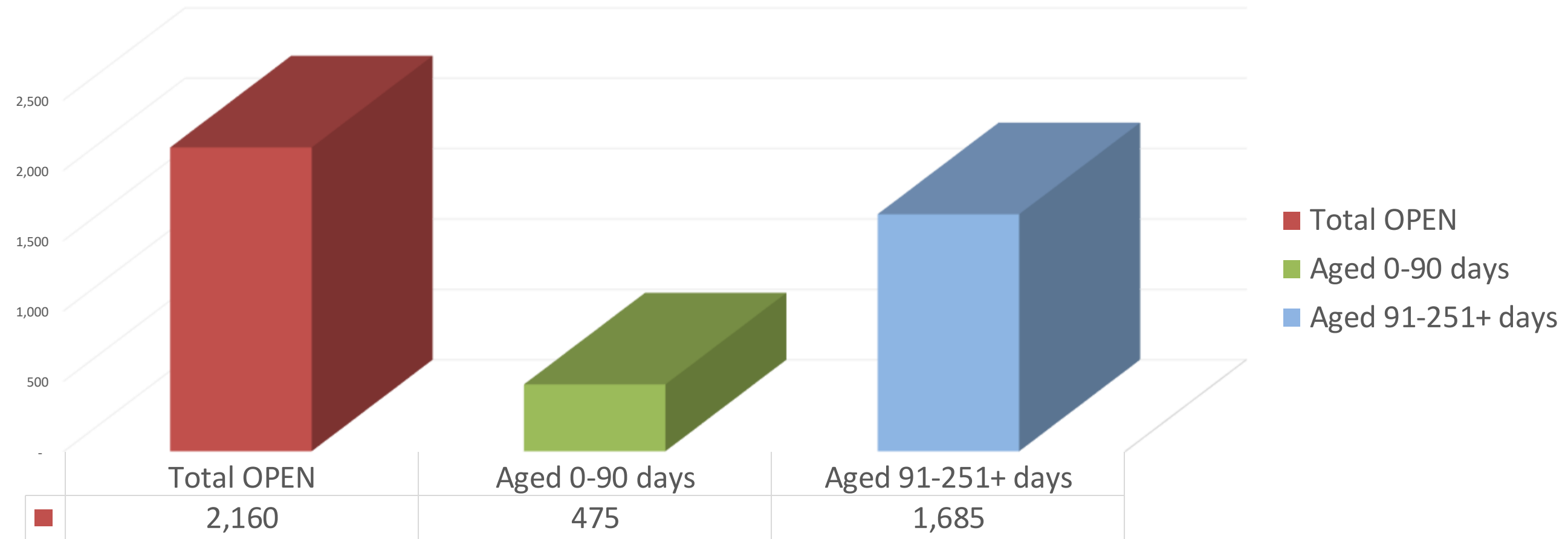
OCI INVESTIGATORS CLOSED 2,546 CASES TO DATE IN 2025
OCI RECEIVED A TOTAL OF 2,145 CITIZEN COMPLAINTS TO DATE IN 2025
This represents a net reduction of 401 cases from our active workload.
We are outpacing intake by more than 84%.





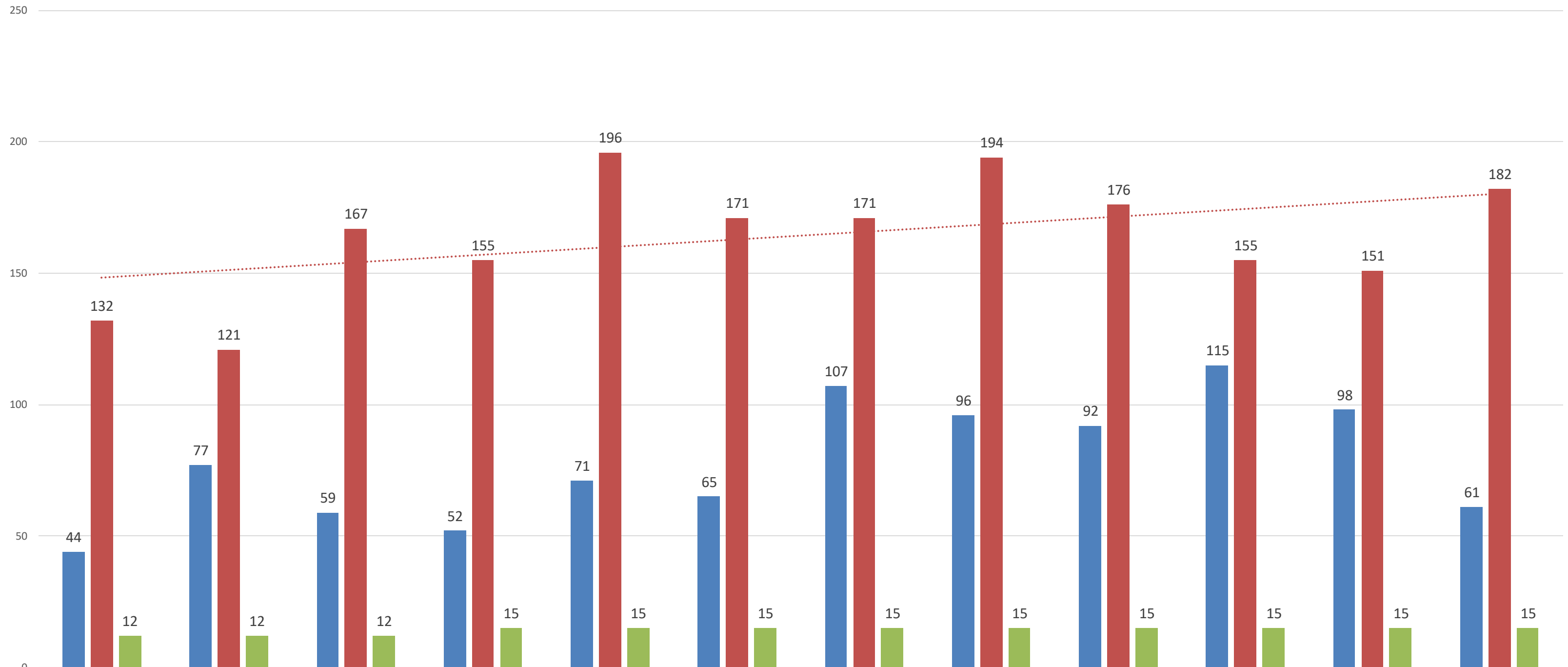
OCI STATS FOR OCTOBER 2025

Total Caseload: Reflecting this progress, our total number of open cases has dropped from 4,840 in January to 2,160 a 44% decrease.

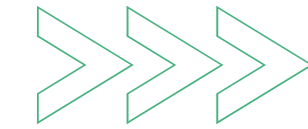
■ Total Cases Closed ■ Total Cases Received ■ Investigators in Rotation Linear (Total Cases Received)

OCI RECEIVED A TOTAL OF 1,971 CITIZEN COMPLAINTS TO DATE IN 2024

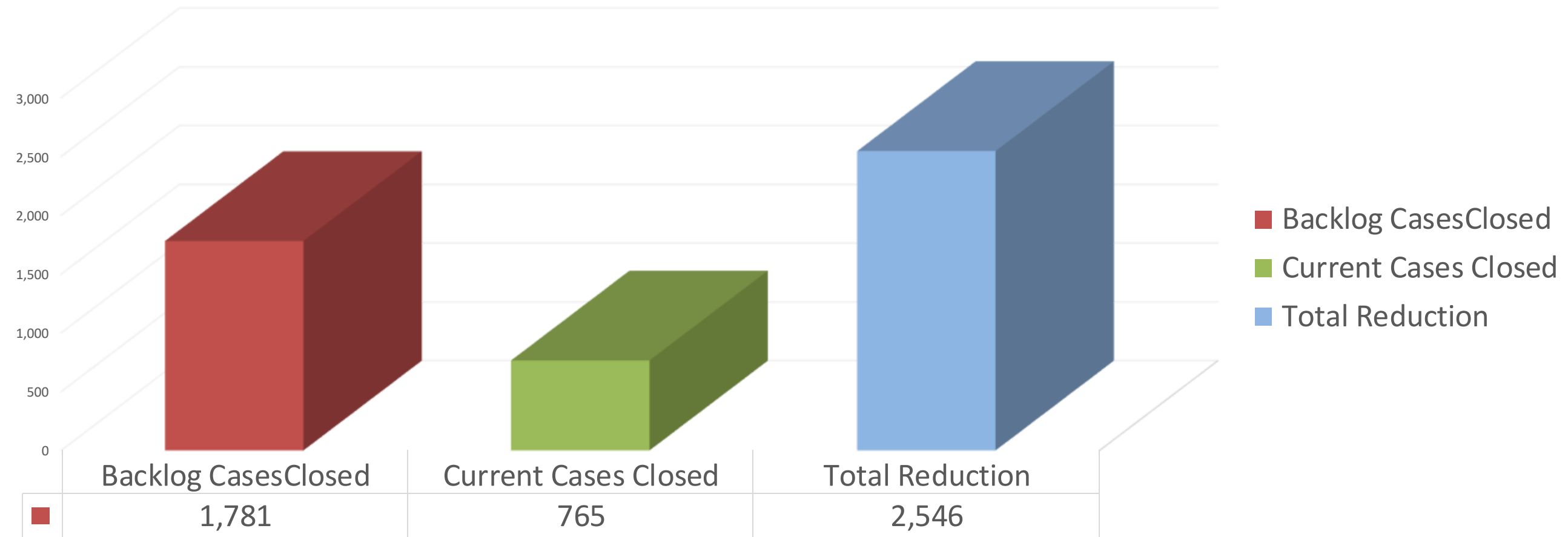
OCI's Progress

We closed **2,546** cases this year. This is a **162% increase** over the 973 cases closed in 2024.

2026 PROJECTIONS

OCI's goal was to close all "**Legacy Backlogged**" cases (2021-2023), while also investigating and closing 2025 cases. This goal was accomplished on December 15, 2025.

Projected Closures of all 2024 cases: 953 will be closed by February 27, 2026.

Projected Closures all 2025 cases: 1,386 will be closed by June 30, 2026 while at the same time staying current on all 2026 complaints.
