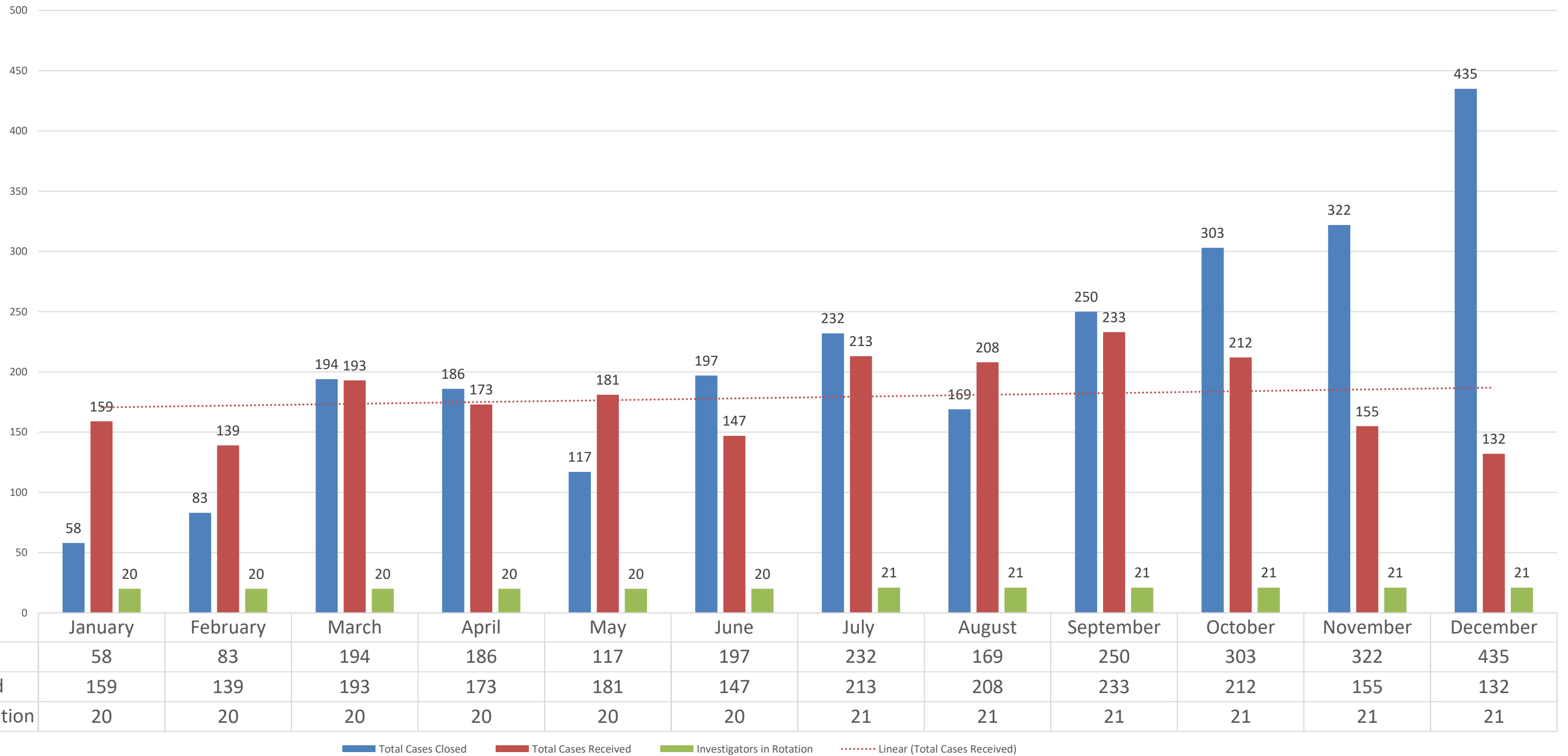
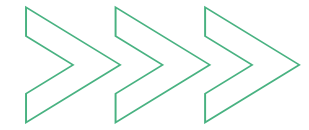


OCI MISSION STATEMENT

CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2025



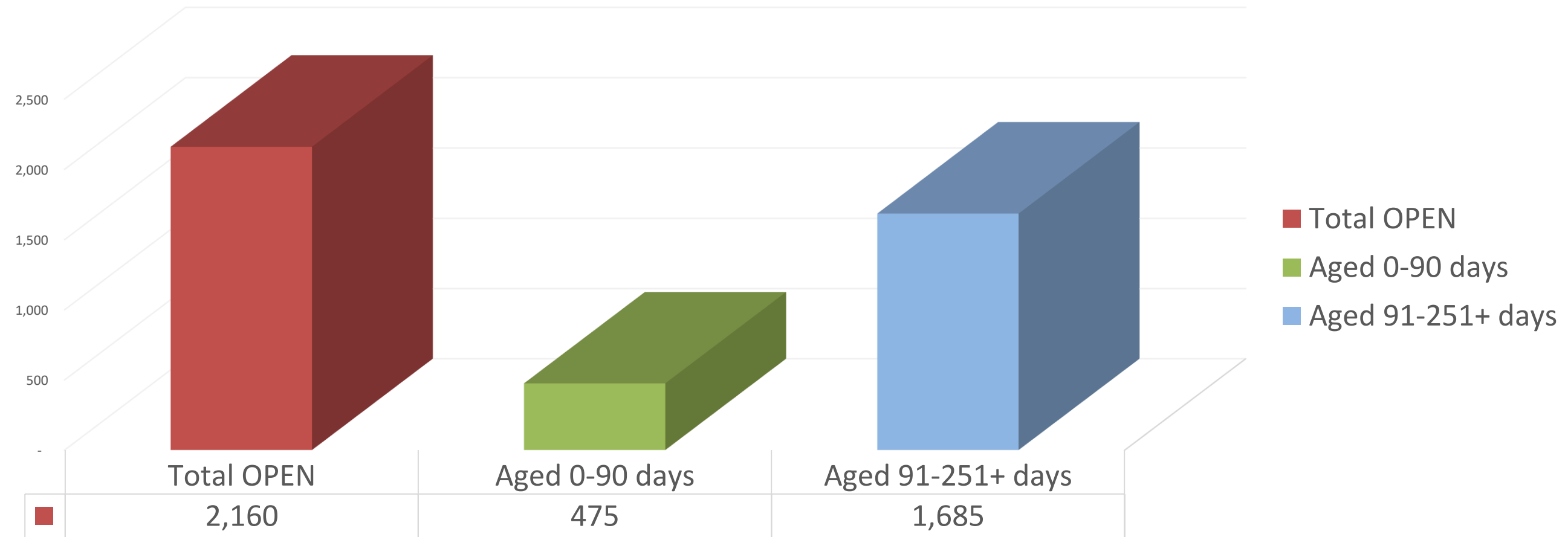
OCI INVESTIGATORS CLOSED 2,546 CASES TO DATE IN 2025
OCI RECEIVED A TOTAL OF 2,145 CITIZEN COMPLAINTS TO DATE IN 2025
This represents a net reduction of 401 cases from our active workload.
We are outpacing intake by more than 84%.





OCI STATS FOR DECEMBER 2025

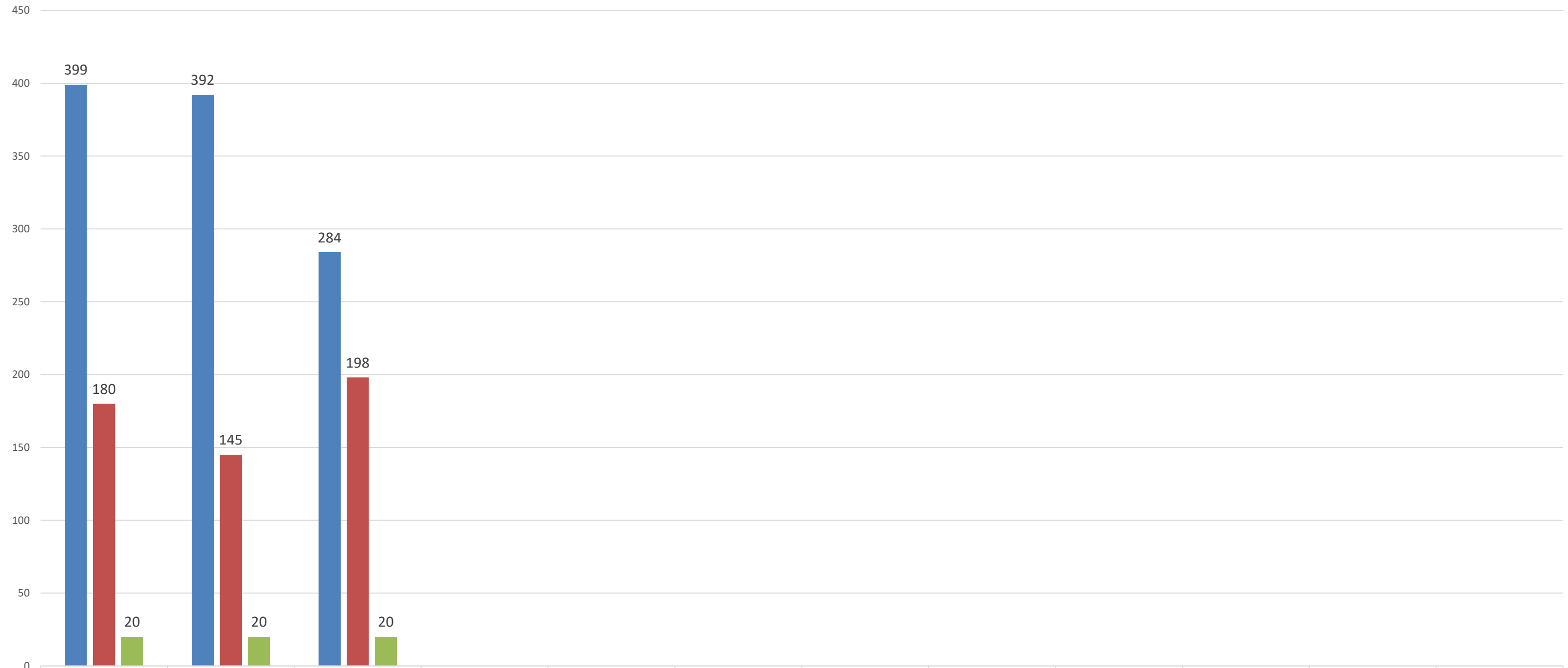
OPEN CASES AS OF DECEMBER 31, 2025

CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2026



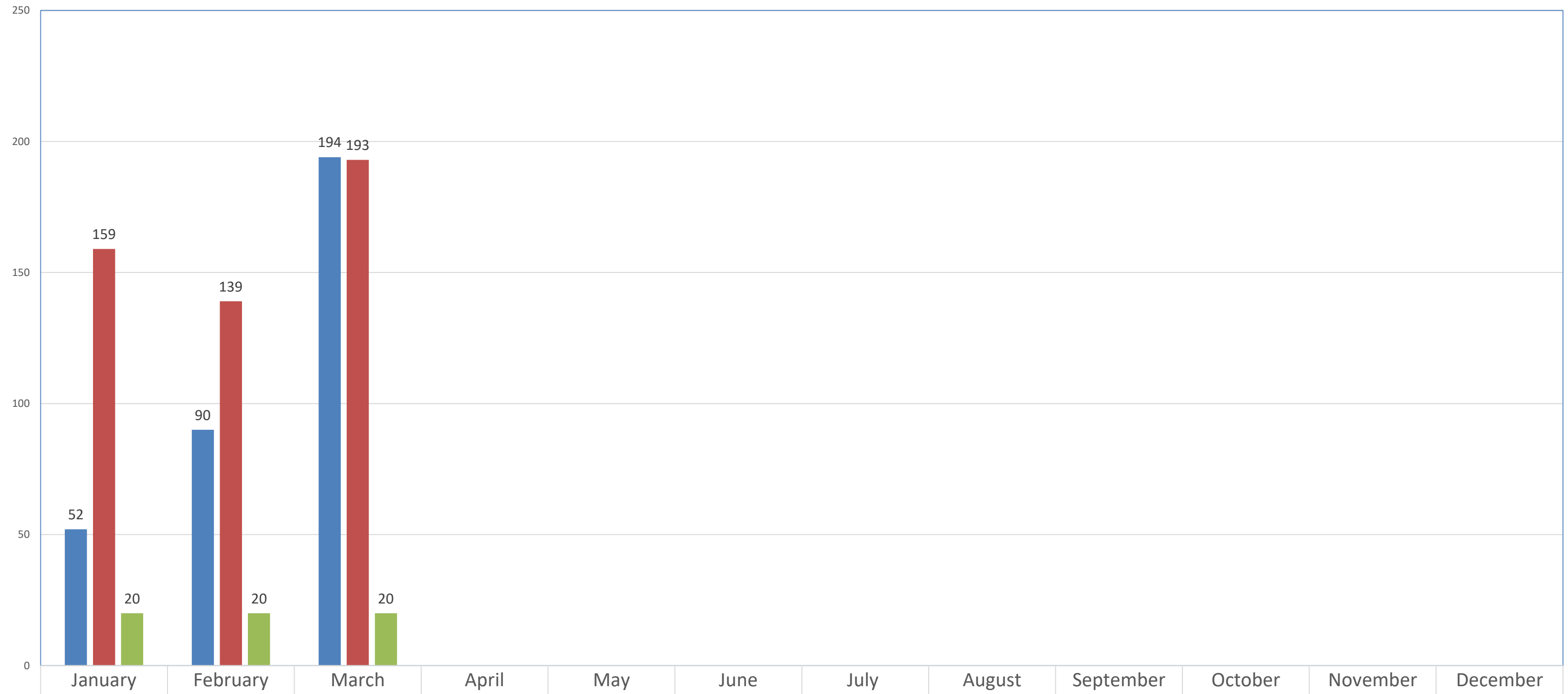
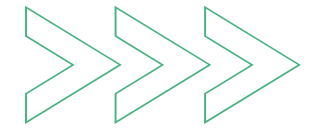

CASES RECEIVED VS CLOSED VS INVESTIGATORS – YTD 2025

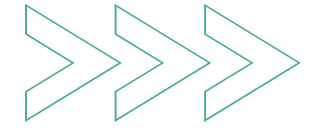

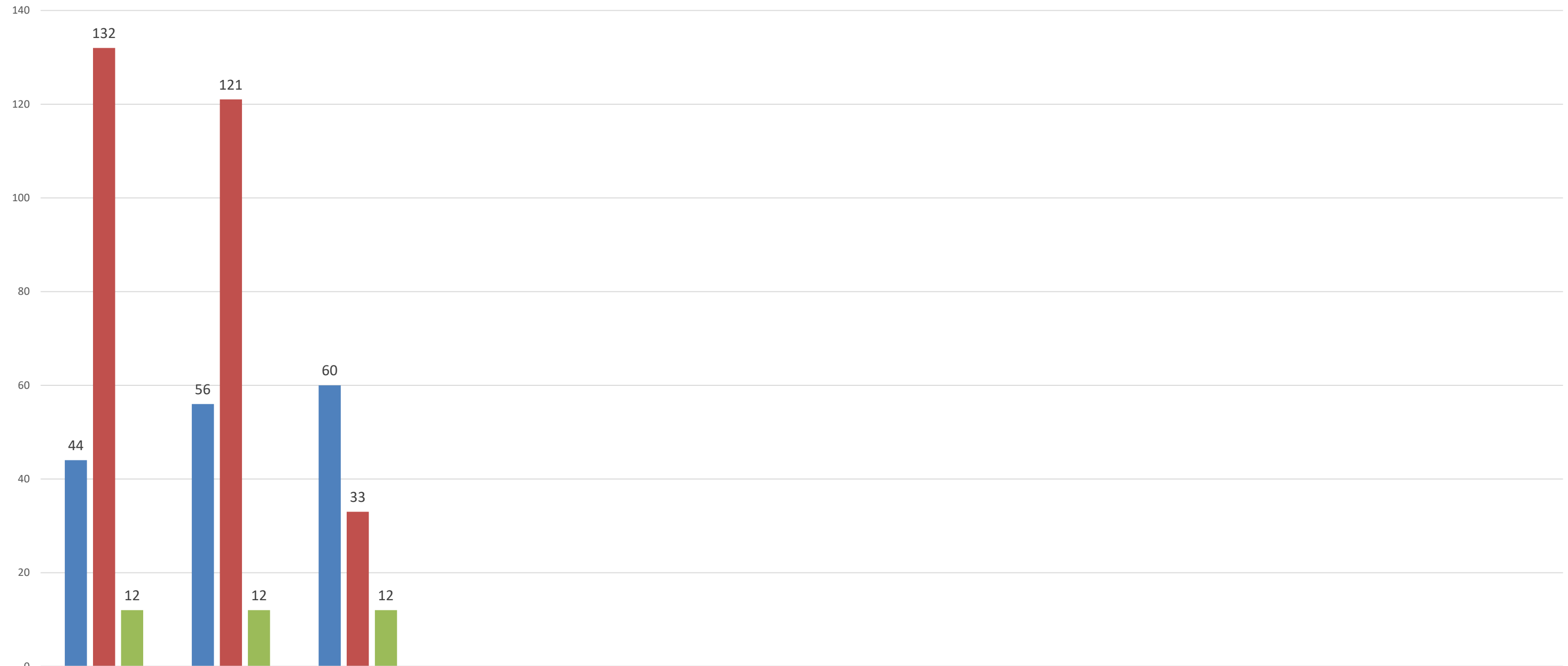

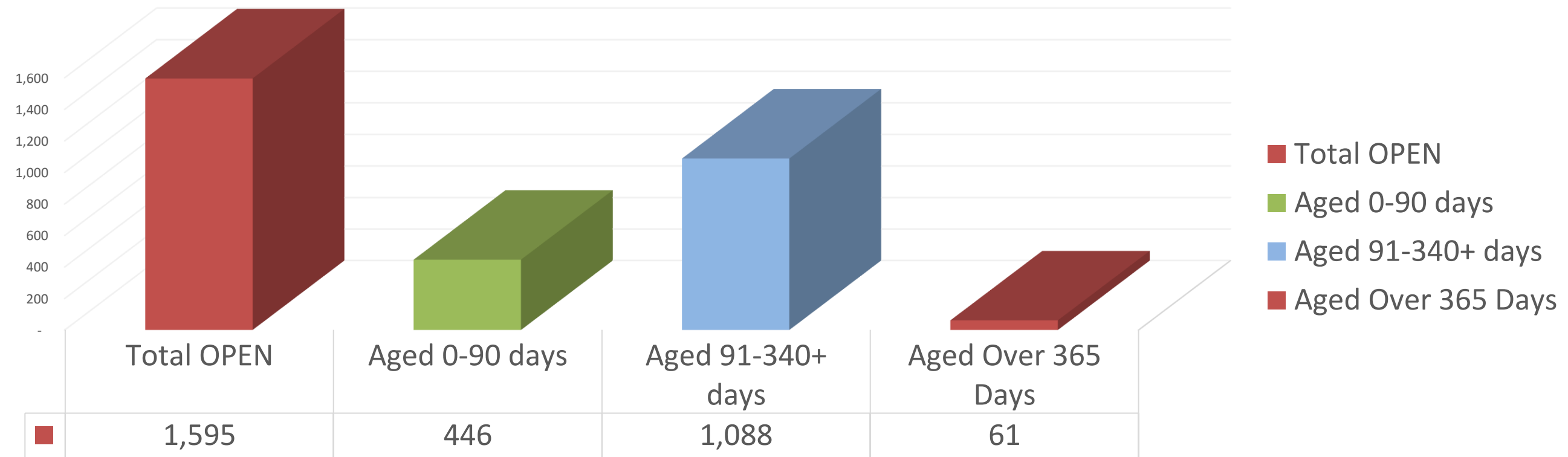
