## **INITIAL REQUIRED DOCUMENTS**

Property owners who apply to the Ford Michigan Central Station Home Repair program must submit documentation with their application. The purpose of these documents is to determine eligibility and establish home ownership. Documents must be valid and current; other documents may be acceptable.

- PROOF OF HOMEOWNERSHIP: DEED OR LAND CONTRACT
   To establish ownership, property owners must submit a <u>deed, land contract, or other document showing ownership</u> recorded at the Wayne County Register of Deeds.
- 2. **PHOTO IDENTIFICATION: MICHIGAN DRIVER'S LICENSE, STATE ID, DETROIT ID, OR MATRICULA CARD**To establish connection between deeded owner and applicant. Government-issued identification, including non-US based forms of Identification, will be accepted.
- 3. OCCUPANCY VERIFICATION: CURRENT DTE BILL (OR OTHER GAS/ELECTRIC BILL FROM THE PROVIDER)
  To establish owner occupancy for a minimum period prior to application.

After review of submitted attachments, additional documentation will be requested to complete the application. This will include:

- O Income verification
- O Status of property tax payment plan (if applicable)
- O Consent of all title holders (if multiple owners)
- O Application affidavit
