# **NOTICE OF DENIAL**

Dear Applicant,

At the regular meeting that was held on October 12, 2022, the Detroit Historic District Commission ("DHDC") reviewed the above-referenced application. Pursuant to Section 5(1) and 9(1) of the Michigan Local Historic District Act, as amended, being MCL 399.205 (1), MCL 399.209 (9) and Sections 21-2-78 and 21-2-80 of the 2019 Detroit City Code; the DHDC hereby issues a Denial for the following work, effective on October 18, 2022, as it will be inappropriate according to the Secretary of Interior's Standards for Rehabilitation and the district's Elements of Design:

Install security door on the front (northeast) façade, per the submitted application and other submitted materials.

The reasons for the denial are a failure to meet the following specific Standards or Elements:

- 2. The historic character of a property shall be retained and preserved. The removal of historic materials or alteration of features and spaces that characterize a property shall be avoided.
- 5. Distinctive features, finishes, and construction techniques or examples of craftsmanship that characterize a property shall be preserved.
- 9. New additions, exterior alterations, or related new construction shall not destroy historic materials that characterize the property. The new work shall be differentiated from the old and shall be compatible with the massing, size, scale, and architectural features to protect the historic integrity of the property and its environment.

The application may be resubmitted for the Historic District Commission's review when suggested changes have been made that address the cited reasons for denial, if applicable.

Please be advised that, in accordance with MCL 399. 211 and Section 21-2-81 of the 2019 Detroit City Code, an applicant aggrieved by a decision of the DHDC may file an appeal with the State Historic Preservation Review Board. Within sixty (60) days of your receipt of this notice, an appeal may be filed with:

Hi Ben,

Attached is my HDC application for security / screen doors.

I have attached current photographs.

The front and side door do not have security doors (they had doors at some point, but none when we moved in). We are having a design which minimizes the look of security doors and goes well with the architectural elements of the house and neighborhood. For the front, we are restoring the arch, which had been removed at some point as there was a wood piece added to accommodate a standard rectangular door.

The doors to the backyard patio are not functional (missing door knobs and latches) and the wood is sagging and rotted at the bottom of each door. We are going with a full window door so the original steel interior doors can be seen and the mullions do not clash. We are able to keep the sidelights on the one set of doors, as those simply screw in and are in good enough shape to be restored.

We looked at various options for these doors and most companies would not even quote us a price because our house is 'old' and not 'standard'. We believe that these steel doors will match and enhance the architecture of the existing home, as well as providing additional functionality, security, and energy savings.

All of the doors will be hunter green, which matches exactly with the original paint color on all of the windows (as seen on the interior steel doors, as well as a picture provided from the garage). The previous owners painted all of the exterior windows brown to match the trim.

This is a very straight forward project to simply install the doors into the existing jambs.

Please let me know if you have any questions. Hopefully this simple job can be approved without the need of a full committee review.

FYI, the manufacturer of the doors didn't know their Detroit License number so I put

the FEIN in that spot.
