### NOTICE OF DENIAL

RE: Application Number 23-8335; 14921 Greenview, Rosedale Park Historic District Project Scope: Install vinyl windows

Dear Applicant,

At the regular meeting that was held on May 10, 2023, the Detroit Historic District Commission ("DHDC") reviewed the above-referenced application. Pursuant to Section 5(1) and 9(1) of the Michigan Local Historic District Act, as amended, being MCL 399.205 (1), MCL 399.209 (9) and Sections 21-2-78 and 21-2-80 of the 2019 Detroit City Code; the DHDC hereby issues a Denial for the following work, effective on May 17, 2023, 2022, as it will be inappropriate according to the Secretary of Interior's Standards for Rehabilitation and the district's Elements of Design:

Replace wood windows with vinyl windows per the submitted documents and other application materials.

The reasons for the denial are a failure to meet the following specific Standards or Elements:

- 2. The historic character of a property shall be retained and preserved. The removal of historic materials or alteration of features and spaces that characterize a property shall be avoided.
- 5. Distinctive features, finishes, and construction techniques or examples of craftsmanship that characterize a property shall be preserved.
- 6. Deteriorated historic features shall be repaired rather than replaced. Where the severity of deterioration requires replacement of a distinctive feature, the new feature shall match the old in design, color, texture, and other visual qualities and, where possible, materials. Replacement of missing features shall be substantiated by documentary, physical, or pictorial evidence.

The application may be resubmitted for the Historic District Commission's review when suggested changes have been made that address the cited reasons for denial, if applicable.

Please be advised that, in accordance with MCL 399. 211 and Section 21-2-81 of the 2019 Detroit City Code, an applicant aggrieved by a decision of the DHDC may file an appeal with the State Historic Preservation Review Board. Within sixty (60) days of your receipt of this notice, an appeal may be filed with:

Good afternoon Ms. Branch-Dawson,

Thank you again for submitting all of this information. I know many folks are having a hard time locating contractors these days.

Staff reviewed all of the materials and determined it is beyond our authority to approve the project. This is not to say it will not be approved, just that HDC staff does not have the authority to approve it and it will need to go before the Commission. We will tentatively schedule your case to be heard at next available Commission meeting on May  $10^{th}$ .

That being said, the Commissioners rarely approve vinyl windows to replace original wood units. However, you are welcome to propose whatever window types you want. I think you would have a better chance of approval if you selected wood or aluminum clad units. Additionally, we respectfully request that you or your contractor send some additional information on the proposed windows. That could come in the form of a product brochure or something similar. The commissioners will want to be able to have an idea of what the final product will look like installed.
