


• Install 14 new static, unlit signs within the public right-of-way/sidewalk area in the above-listed historic districts per the submitted documentation. Each sign will include multiple 4" to 6" double-sided metal plates which are affixed to a metal pole that is bolted into the sidewalk. Each sign will measure 12'-9' in height.


