At the Regular Meeting that was held on April 10, 2024, the Detroit Historic District Commission ("DHDC") reviewed the above-referenced application. Pursuant to Section 5(1) of the Michigan Local Historic District Act, as amended, being MCL 399.205 (1) and Sections 21-2-73/21-2-78 of the 2019 Detroit City Code; the DHDC hereby issues a Certificate of Appropriateness ("COA") for the following work, effective on April 16, 2024, as it meets the Secretary of Interior's Standards for Rehabilitation and the district's Elements of Design:

DEMOLISH GARAGE & REAR STOOP/STEPS

- Demolish garage, remove all materials, regrade per submitted site plans.
- Demolish rear porch stoop and rear porch steps per submitted site plans.
- Move HVAC equipment to north, rear side of house per submitted site plans.

CONSTRUCT NEW GARAGE

- Construct new, 24'x24' garage in location slightly moved within setback of property line over concrete slab per submitted drawings. Garage shall be 17' 6" height pyramid hipped roof with brick cladding (Antique Red Blend multicolor, wire-cut brick), wood windows with limestone sill and wood entry door to match existing home.
- Install asphalt shingles, color sand to match existing home
- Paint all trim dark grayish olive, Color System D.
- Install Clopay steel garage door with 4x2 grid windows, painted dark grayish olive.
- Install wall-mounted, lantern-style 19.5" sconces (2) model# OL5401 per submitted plans.

REPLACE REAR STEEL CASEMENT WINDOWS with FRENCH DOOR OPENING

- Remove (1) pair casement windows and remove the limestone sill for reuse.
- Construct new door opening, re-install original limestone sill.
- Install Marvin Ultimate Wood French doors with 4x6 grid per submitted drawings.

CONSTRUCT REAR DECK

- Erect 12'x29' rear cedar wood deck as shown in submitted drawings.
- Attach black metal hand railing per submitted drawings.

INSTALL REAR PATIO AND MODIFIED DRIVEWAY

- Install 24'x12'7" concrete paver patio per submitted drawings.
- Modify concrete driveway location to match new garage location per submitted drawings.

LANDSCAPE

- Install planting bed surrounding proposed deck and rear patio per submitted drawings. •
- Plant with assorted perennials and annual plants. •

The Certificate of Appropriateness is issued with the condition that:

The electric line will be moved away from the doorway. •
