Entitled "E. W. Voigt's subdivision of Voigt
Park Farm, part of $\frac{1}{4}$ Section 36, 10,000 Acre
Tract, Detroit, Wayne County, Michigan."

First parties dedicate to the public the per-
petual use of the parks and esplanades, ave-
nues and alleys as represented on said plat
reserving the reversion thereof provided that
if the names of Schiller and Shakespeare es-
planades or either of them shall at any time
hereafter be changed, then this reservation to
become operative as to such esplanade, pro-
vided further that if the said esplanades, ave-
nues or alleys shall ever be vacated as public
highways, then this reservation to become
operative, provided further that if the name of
said Voigt Park shall at any time hereafter
be changed or its use as a public park in any
manner discontinued or abridged, then this
reservation to become operative as said park
and provided further that if the 50 foot strip
of ground in the center of Schiller and Shake-
speare esplanades shall ever be used for other
than park and ornamental purposes, then this
reservation to become operative.
