Good morning,

Thank you for the confirmation.

I have some additional comments on [HDC Application 2025-00576](#) for Voigt Park. I would request that if the Historic District Commission decides to approve this application, that it only does so **with the following conditions:**

1. Reduce the width of the pathway to 3ft.
2. Change the material of the pathway from concrete to a permeable surface (gravel, aggregate, compacted soil, etc)
3. Remove the concrete pads for the benches and trash receptacles - instead anchor these elements to buried concrete posts, or another method which is not visible above ground
4. Require that the Detroit Parks Department not begin construction of the pathways until they have funds secured to complete the whole pathway. I understand that the City currently has funding for 1/3 of the path and plans to construct only that portion next year. Sources of future funding to complete this plan have not been identified or secured, so we do not know when, if ever the remainder of the path will be completed. A partially completed path which does not connect to anything is not a condition that the neighborhood wants to see the park left in, nor do we wish to endure multiple construction phases disrupting use and enjoyment of the park.
5. Request that the Parks Department makes plans and dedicates resources for additional tree plantings in the park. The 18 trees planted last year was a wonderful start. Residents would greatly appreciate further progress towards the goal of 100 new trees in Voigt Park to restore the historic forest canopy after many trees have been lost through the years due to severe weather and disease.

Regarding alternative path materials used in Detroit Parks mentioned in my previous comment. Please see photos below from Campus Martius, Cadillac Square and Belle Isle where gravel, and compacted soil are used to create permeable and natural walking paths.

Thank you again for your attention to these concerns.

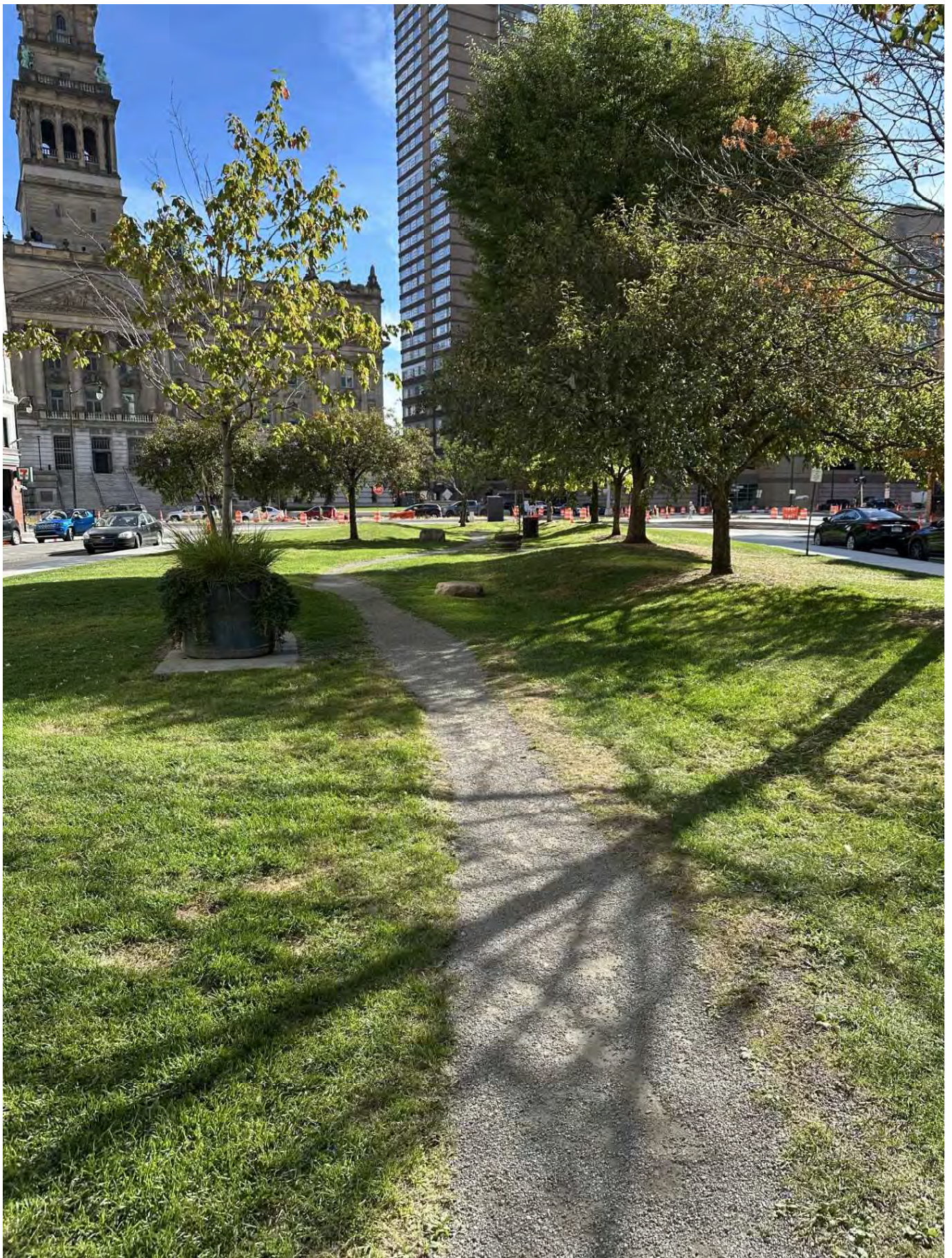

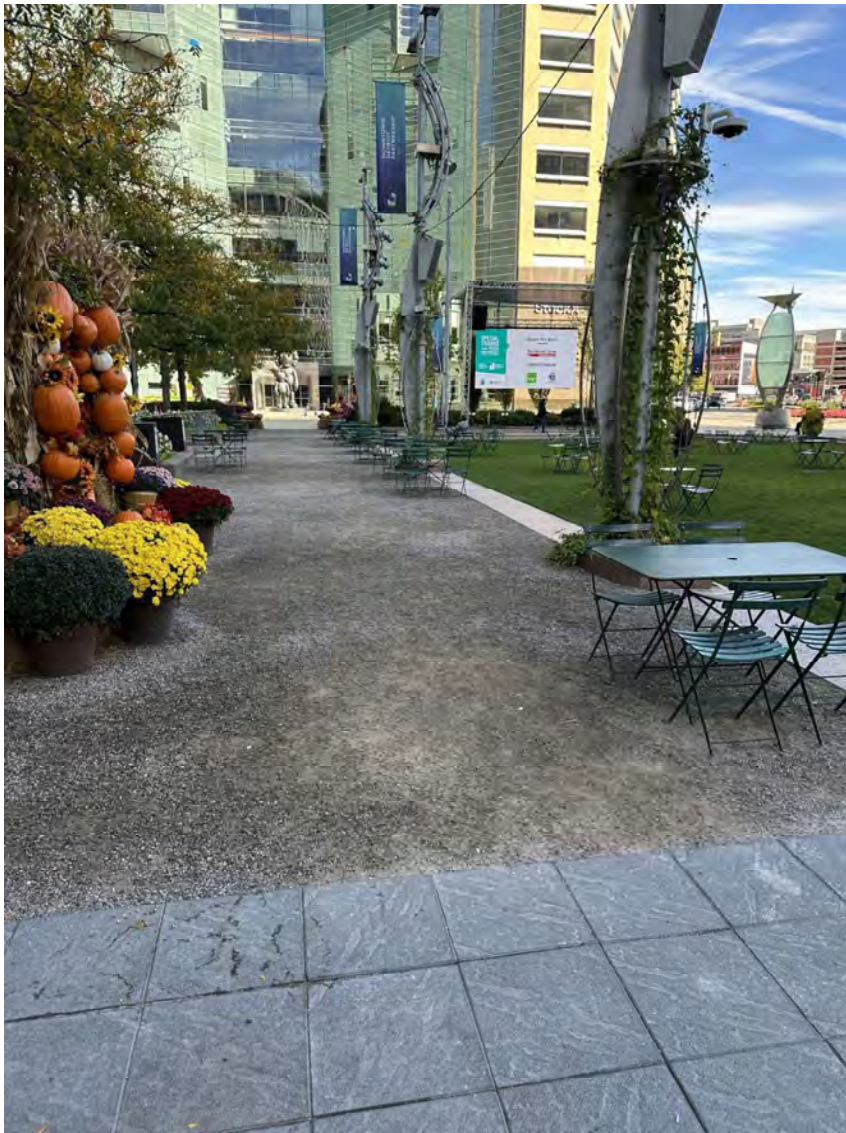

Dear Historic District Commission,

I am writing in regards to [HDC Application 2025-00576](#) to be considered at the [October 8, 2025 Historic District Commission meeting](#).

As a resident living adjacent to Voigt Park for over 10 years, I have enjoyed the natural beauty and respite afforded by the park nearly every day and in all seasons. I am also a member of the Voigt Park Neighborhood Block Club since its beginning in 2019, and have taken an active interest in the care and maintenance of the park. The discussion of future improvements to the park is not a new topic, however I am concerned by the proposal for Voigt Park that is now before the Historic District Commission.

In its current form, **I do not support the proposed plan** for installing new infrastructure in Voigt Park. While I do not oppose restoring the historic paths, or adding benches, and trash receptacles, I am deeply concerned by the design and plan as it is currently proposed - as well as the Parks Department's lack of resident engagement before proposing these changes. **I respectfully request that HDC not approve the current plan presented**, allowing the City of Detroit Parks Department to engage the community on the proposed amenities and return with a revised plan based on the feedback of the neighbors and users of Voigt Park. Specifically, I have the following concerns regarding this application:

- **The excessive width and elevation of the proposed park paths.** The planned paths are overly obtrusive and will cause visual blight to Voigt Park's historic natural landscape due to their proposed 6ft width and the plan to have them elevated above ground level. 6ft paths are wider than the sidewalks in front of many of our homes and accessible path standards only require 3ft in width. **In order to minimize the visual impact of the paths on the historic landscape, the paths should be reduced to 3ft and installed to be flush / level with the ground.**
- **Impervious concrete pathway materials.** Seasonal flooding and stormwater runoff are ongoing issues for Voigt Park, and the addition of significant amounts of impervious concrete will only serve to exacerbate the issue. There are many permeable solutions available while maintaining accessibility standards and not detracting from the historic landscape. I would note that some of our City's most recognized and celebrated parks, such as Campus Martius and Cadillac Square (notably located in Historic Districts) make good use of natural materials for walkways instead of concrete. See the attached photos of pathways from those parks. **The Voigt Park paths should be revised to be constructed of natural and /or permeable materials to enhance the look and feel of the historic landscape.**

- **Installation of benches and garbage receptacles on concrete pads.** Similar to the issues above, concrete pads for these amenities are unsightly, impervious, and unnecessary. **I urge the City's Parks Department to utilize a different method to secure these items in the park - such as anchoring to an underground concrete post.**
- **Community input on design and materials for park amenities.** According to the [Detroit Parks Department's Strategic Plan](#), Voigt Park is slated for a parks planning process in "Phase 4 - 6", taking place sometime between 2026 and 2028. The City of Detroit Parks Department usually conducts a standard community engagement process when planning upgrades to its parks. Unfortunately, the plans presented to HDC have not been formed in any sort of public process. While I understand that the Parks Department has had several private conversations with the Historic Boston Edison Association (HBEA) and Voigt Park Neighborhood Block Club, the broader community has not been engaged on these proposed changes. The Block Club has been proactive in letting neighbors know about the plans and gaining feedback, but that is not a substitute for the Detroit Parks Department taking responsibility to engage with residents before moving forward with such a significant change to Voigt Park. Ideally, any decisions about park improvements, design, and materials should be determined at the time of the Voigt Park's scheduled planning process in Phase 4 - 6 of the City's Parks Strategic Plan. **At a bare minimum, I request that the Parks Department hold at least one Design Charette with neighbors adjacent to Voigt Park so that consensus can be reached on the design of these elements.** Additionally, feedback should be sought on improving the tree canopy and mitigating seasonal flooding in the park - which have long been identified as priorities for the neighbors living near and using Voigt Park. We have worked successfully with the Detroit Parks Department to plant and maintain trees in the park - but many more are needed to restore Voigt Park's historic forest canopy of hardwood and native trees.
- **Timing of Improvements - no partial construction, prioritize interim improvements via tree planting and flooding mitigation.** I understand that the City only has funding to complete approximately one third of the pathways at this time, with no guarantee or identified source of funds to complete the remainder of the paths. **In order to minimize disruption to the park and park users through multiple construction periods, the City should not commence with construction of paths until they have the resources to complete the pathway.** This will also allow time for the City to conduct additional outreach and engagement, ensuring that the plan is supported by neighbors. In the interim, **I request that the City continue to prioritize the health of Voigt Park's historic forest by planting additional trees as well as studying the seasonal flooding issues** and making a plan for mitigating the standing water issues that is a barrier to the use and enjoyment of the park several months out of the year.

I thank the Historic District Commissioners and the City of Detroit Parks Department staff for their attention to this important issue for our neighborhood. I am fully confident that when the Parks Department engages with the residents who live adjacent to and use Voigt Park, we can have a plan for our beloved park that truly reflects the desires and priorities of our neighbors.

Thank you for your attention to this matter and your commitment to preserving Detroit's history, buildings and landscapes.
