


We are happy to provide the additional information you have requested.

1. Photos of roof prior to current work attached. This shows the condition assessment with the slate falling off due to the nail heads failing. Gregory has saved all the failed nails and slate.



- 2. Gregory Varano(homeowner)does all the work so we did not get any estimates. The 130 year old nail heads had deteriorated and the nails no longer could hold the slate so the slate was falling off piece by piece. This is evident in the attached photos. It would not have been feasible to repair the existing 10,000 pieces of slate that were failing off the roof one by one.
- 3. Interior photos/evidence of leaking attached. There were 17 areas of roof leaking.





4. We do not have any information to share about previous owners' repairs. We have owned the home since 1993.
