The current status is that the new shingles are being installed. This project began in 2017. We did not know we needed to apply to the Historic Commission for approval so we are doing that now.

### Description of Project for 461 W Forest Ave:

Original slate roof from 1890 was still on our home. As time goes on the nails deteriorate and the slate would fall off the roof. Repairs had been made on occasion but the time came to replace the roof. The original slate was carefully removed, piece by piece. Grace Ice and Water Shield was applied to entire the roof and GAF Slateline Royal Slate Asphalt shingles are being applied to the entire roof.
