## **Existing Condition:**



Existing Condition Photo 1: Original height of door & frame were lowered as a result of the existing canopy. A new door was also added in the existing frame to fit this reduced height.





Existing Condition Photo 2: The existing door & frame were infilled in the original frame. The existing door has significant material loss through aging & weathering. With the removal of the canopy, the existing door in this photo (or a replica of this door) will not achieve a historically accurate façade.
