BENCH MARK #1: ARROW ON FIRE HYDRANT LOCATED ON THE NORTHWEST CORNER OF JOHN R ST. AND ADAMS AVE.
ASSUMED ELEVATION=100.00

BENCH MARK #2: THE SOUTHEAST BOLT ON THE LIGHT POLE LOCATED AT THE NORTHEAST CORNER OF JOHN R ST. AND MADISON AVE. ELEVATION=98.58

BENCH MARK #3: ARROW ON FIRE HYDRANT LOCATED ON THE SOUTHWEST CORNER OF MADISON AVE. AND RANDOLPH ST. ELEVATION=99.94

BENCH MARK #4: BASE OF LIGHT POLE LOCATED IN THE PARKING LOT SOUTH OF THE PARKING STRUCTURE AND EAST OF THE D.A.C. ELEVATION=97.77

BENCH MARK #5: SET "X" IN LIGHT POLE BASE LOCATED IN THE PARKING LOT LOCATED ON THE SOUTHEAST CORNER OF ADAMS AVE.
