So far only the floor plans and elevation drawings have been submitted. The building department will require the section drawing(s).

  - Site plan showing all changes and landscape features, including location of construction fencing if applicable
  - Floor Plan(s)
  - Elevation Drawing(s)

Additionally, I learned that a privacy fence was recently erected at the front of the lot, completed without HDC approval. This should be included with your application and shown on the site plan, along with the explanation if it is temporary due to construction, or if you expect it to be permanent.

Now that you are coming back with a new proposal and have the dimensioned floor plan/elevations, the application needs to include the dimensioned site plan. The site plan must include all construction and landscaping/fencing plans that relate to this project.

I can extend the deadline until 5:00 p.m. today, otherwise this application will be moved to the September agenda. In the meantime, please submit information on the installed fence, as this is a violation.
