Exiting lots have been combined into 1 lot. The north lot has the house on it and the south lot is vacant. We are proposing a fence around the 2 lots that consists of a stone wall with wrought iron fencing on top for the west border of the property. This fence will align with the street side front of the apartment building to the North. See detail #2 on page A1.1.

The south fence line will have a higher stone wall with a wrought iron fence on top that will encompass an earth berm on the south edge of the property. See detail #4 on page A1.1.

The east edge of the property will have a wood wood fence with a 20' gate that butts up against the new garage.

Place trench footings at all wall locations, have a wrought iron or similar fabricator install the fence into a block wall with stone facing the street and brick facing the yard.

The berm will have a number of mid-high trees and an understory of appropriate vegetation. the low side of the berm will have a low wall to match the west fence line.

The wood fence will have post hole foundations and a gate.
