The original application included new facade cladding at the east bay of the alley facade which was formerly infilled with CMU. When the CMU was removed, existing limestone with punched window openings was uncovered. See attached letter for additional information.

This is a revision/amendment to Application #23-8236 & #23-8247 and the COA dated 3/20/23. The originally approved GFRC cladding has been changed to composite metal panels, a significant reduction in weight. The alley windows have been changed from 1-1 equal sash single hung windows to asymmetric single hung windows with an operable lower sash with a height more consistent with the primary façade windows.
