Jennifer -

Regarding application HDC2025-00650, the scope of work shall be considered incomplete unless demolition of the previously existing garage is included by the applicant. Incomplete applications cannot be reviewed by the Commission.

The reason for this is that a new garage cannot be built in the same location without legal removal of the previous garage. The demolition is a required precedent step that must occur for the existing application to be valid, and therefore must be accounted for in the scope of work. We have no record of approval for removal/demolition of the previous garage. The Commission cannot add scope to applications, only the applicant can do that.
