- c.1950: Garage first appears on map

Convent (present-day wellness center)

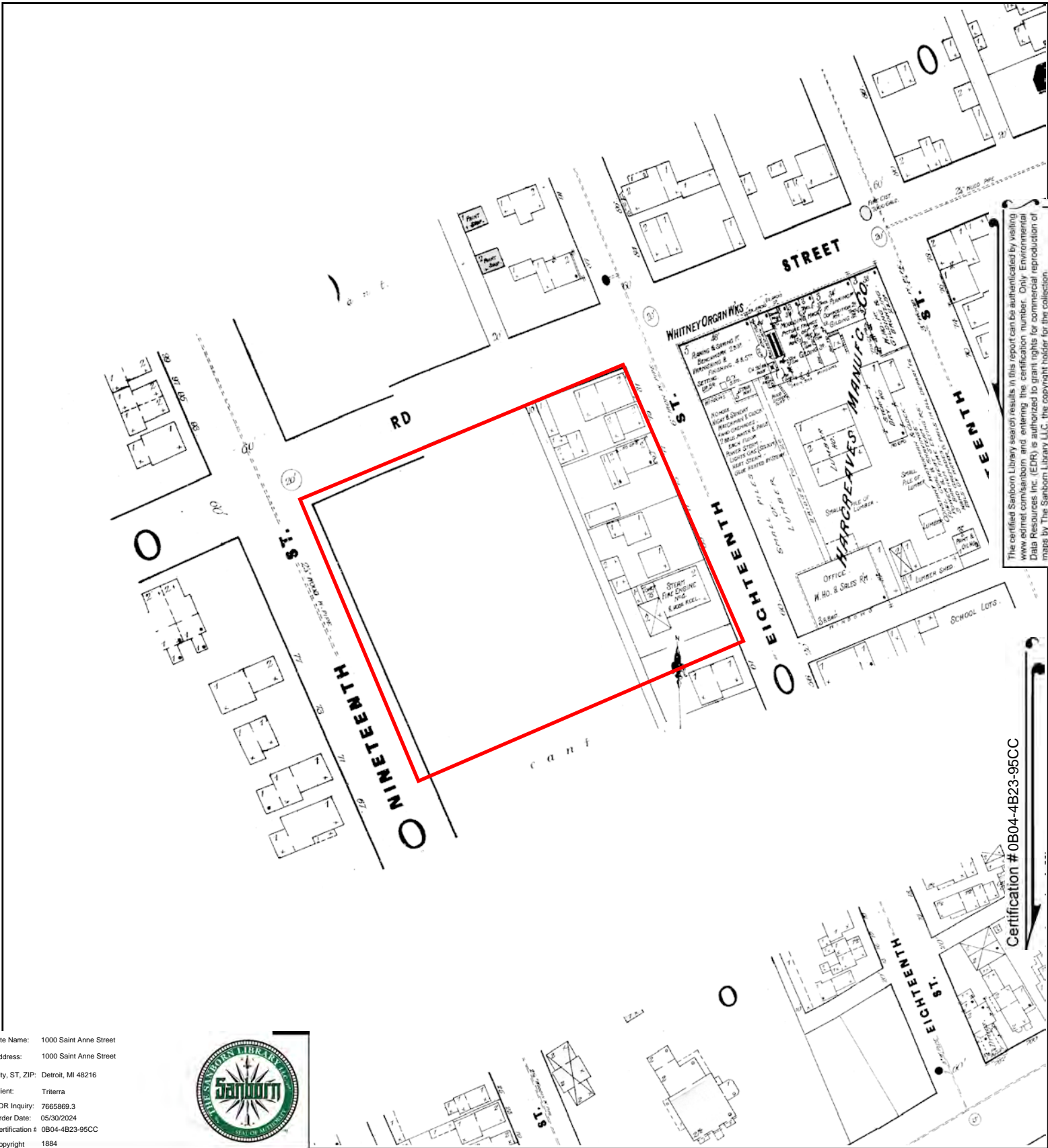
- 1889: initial construction

- 1898: initial construction
- c. 1921: NW exterior stair first appears on map
(Note: The small brick lean-to/shed structure at the northeast corner of the building does not appear on any Sanborn maps seen to date.)

Boundaries of the Ste. Anne's Parish Complex Historic District, as shown on the map on file in the Office of the City Clerk, are as follows:

On the south the center line of West Lafayette Boulevard; on the west the center line of Ste. Anne Street; on the north the center line of Howard Street (now closed); and on the east the center line of the north-south alley lying between Ste. Anne Street and 18th Street. The legal description is lots 1 through 17 of Canfield's Subdivision of the Loranger Farm, which is found at Liber 7, Page 82, of the County of Wayne Tract Index.



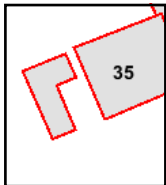
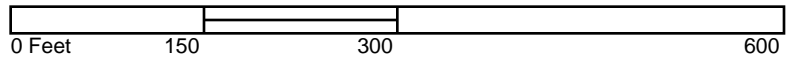
