Introduction

The City of Detroit is requesting proposals from qualified and experienced firms for the installation, operation, maintenance, and management of publicly accessible self-service electric vehicle charging stations (EVCS) in the public right-of-way and on City-owned property throughout the City of Detroit.

The Contractor shall design, build, operate and maintain (DBOM) EVCS, including the furnishing and installation of hardware with accompanying software implementation for facilitation and management of EVCS, primarily for public use in the City of Detroit. All electric vehicle (EV) charger installations must have the ability to provide and receive an API interface with the City of Detroit's enforcement systems allowing for enforcement integration and two-way commencement of charging, meaning the ability to indicate charging from a charging station or parking meter.

Furthermore, the City desires to enter into a revenue sharing model with one (1) or more firms as a result of this Request for Proposals (RFP). The Contractor shall be responsible for all costs associated with the deployment of EV charging station infrastructure, shall collect revenue for providing EV charging services to vehicle owners, and shall share a percentage of that revenue with the City under this model. Respondents will be required to provide details on their proposed EV charging station solutions, their proposed cost to customers (in \$/kWh), and the proposed revenue sharing percentage with the City of Detroit (e.g. xx%).
